Who should use this form?

This form is for use by applicants for a General Skilled Migration (GSM) visa. A summary of the GSM visas has been provided on pages 2–5 of this form. Further information about each visa, including application requirements, is available at the Department of Immigration and Citizenship (the department) website www.immi.gov.au/skilled/

If the visa subclass that you wish to apply for is NOT listed in pages 2–5 do not complete this form and check the department's website www.immi.gov.au for more information. Alternatively, you can contact the nearest office of the department in Australia or the nearest overseas Australian mission. Contact details are available on the website.

Applying online

The department encourages applicants to apply online. **Applications lodged online have quicker processing times.** For information on how to apply online go to the department's website www.immi.gov.au/e_visa/

If you are applying online for a GSM visa that requires sponsorship then the sponsorship form must also be completed online.

Applying on this form

Before completing this form, please read carefully the information below and the information on GSM www.immi.gov.au/skilled/

The GSM visas are divided into 2 categories: **onshore and offshore.**

You can only apply for an 'onshore' GSM visa while you are in Australia, and you can only be granted an 'onshore' visa while you are in Australia.

Applications for an 'offshore' GSM visa are usually made from outside of Australia, however, you may make an 'offshore' visa application while in Australia provided the conditions attached to your current visa do not prevent you from doing so.

Applicants for an 'offshore' visa should be aware that it is a requirement of these visas that the applicants be outside of Australia for a visa to be granted. There is one exception to this requirement where the main applicant is a New Zealand citizen and in Australia as a holder of a Special Category (subclass 444) visa. In this case you may be inside or outside of Australia and the time your visa is granted.

Visa Application Charge

A GSM visa application is subject to a charge. To check the Visa Application Charge, see form 990i *Charges* available from the department's website www.immi.gov.au/allforms/990i.htm or contact the nearest office of the department in Australia or the nearest overseas Australian mission.

Payment **must** accompany your application. If you intend to pay by credit card, please provide details in **Part P**.

Method of payment

To make a payment, please pay by credit card, debit card, bank cheque or money order made payable to the Department of Immigration and Citizenship. Debit card and credit card are the preferred methods of payment.

An alternate option is to make a payment at the nearest office of the department, if you are in Australia, or the nearest overseas Australian mission, if you are outside Australia. If you choose to pay in this way you must attach the departmental copy of the receipt to your application form as evidence of payment.

You **must** lodge your application with the Adelaide Skilled Processing Centre (ASPC), but you can make a payment at the nearest office of the department in Australia or the nearest overseas Australian mission.

Making a valid application and supporting documents

To make a valid application you must provide certain supporting documents with your application. The documents required are different for each type of application. If you do not provide the required documents your application may not be valid and may be returned to you.

You will find the **checklists** of the documents you must provide in support of your application on the department's website www.immi.gov.au/skilled/

You must complete the appropriate checklist from this website if you are sending your application by mail or courier. If you are applying online, the electronic form has an in-built checklist.

In either case, enclose/attach copies of all documents listed on the relevant checklist with your application.

You may be asked to provide other documents during processing. 'Certified copies' of documents means authorised or stamped true copies of originals by a person or agency recognised by law of your country. In Australia, they must be certified by a Justice of the Peace or Commissioner for Declarations or by a person before whom a statutory declaration may be made. The department also accepts documents certified by a registered migration agent.

Documents in languages other than English should be accompanied by an English translation. If the applicant is onshore, the translation should be undertaken by a translator accredited by the National Accreditation Authority for Translators and Interpreters (NAATI). Failure to do so may significantly affect the processing of your application. Translations provided by non-accredited translators overseas should be endorsed by the translator with their full name, address, telephone number, and details of their qualifications and experience in the language being translated.

Note: You must include **both** a certified copy of the original language document **and** a certified copy of the translated document with your application. Do not supply any original documents with your application, unless you have been asked to do so.

Who is covered by this form?

The application form covers a primary applicant and, if applicable, secondary applicants.

For information about who can be included in your application as a secondary applicant, see the department's website www.immi.gov.au/skilled/

If you have a spouse, or interdependent partner, consider which of you is more likely to meet visa requirements before completing the form. The person who meets the age, skill, work experience or study requirements should be the **primary applicant** and complete **Part B About you**.

Dependent children

A dependent child may be your, your spouse or your interdependent partner's natural child, adopted child or step-child. 'Step-child' means a natural or adopted child of your current spouse or a natural or adopted child of your former spouse where the child is under 18 years of age and you have a legal responsibility to care for them (for example, where your former spouse is deceased and you have legal custody of the child). You will need to provide a certified copy of the overseas or Australian court order in relation to the custody of the child. A child aged 18 years or over is not considered dependent if he or she is married or in a de facto/common law relationship or is engaged to be married. A child aged 18 years or over will not be considered dependent unless you can show that they are wholly or substantially reliant on you for financial support for their basic needs of food, shelter and clothing. You must also show that you have provided that support for a significant period and that the child is more reliant on you than on any other person or source. Unless you can provide evidence of this, they should apply separately. You should also be aware that a child aged 25 years or over will generally not be considered dependent. Children of any age who have a total or partial loss of bodily or mental functions, which stops them earning a living, are regarded as dependent and part of the family unit (whether or not they migrate with you). Give details of such children and whether or not they are in your care.

In all cases you should attach evidence of your child's dependency on you.

Custody requirements

The department will seek to ensure that allowing a child to migrate is not in contravention of Australia's international obligations in relation to the prevention of child abduction. If your application includes a child under 18 years of age and the child's other parent is not migrating with you or there is any other person who has the legal right to determine where the child can live, you will need to provide a Statutory Declaration from each of them giving permission for the child to migrate. Alternatively, you can provide a certified copy of a valid court order showing that you, or your spouse or interdependent partner, has the legal right to remove the child from the country.

Other dependants

You may include other relatives in your application if they are wholly or substantially reliant on you for financial support for their basic needs of food, shelter and clothing and they have been reliant on you for that support for a substantial period. They must also be more reliant on you for support than on any other person or source. A relative may also be considered dependent on you if they are reliant on you for financial support because they have a mental or physical disability which stops them from earning a living to support themselves. Other relatives dependent on you, your spouse or your interdependent partner may include, for example, an aged, unmarried relative.

A form 47A Details of child or other dependent family member aged 18 years or over must be completed for each dependant aged 18 years or over, whether migrating or not. The dependant may need to provide supporting documents. Form 47A is available from the department's website www.immi.gov.au/allforms/

About the information you give in this form

The department is authorised to collect information provided on this form under Part 2 of the *Migration Act 1958* 'Control of Arrival and Presence of Non-citizens'. The information provided will be used by the department for assessing your eligibility for a visa to travel, enter and remain in Australia. It may also be used for other purposes relating to the administration of the Migration Act, for example, to assist migrants with settling in Australia, to monitor the conduct of migration agents or for ensuring compliance with the Migration Act.

If you come from a country where the government has issued you with a unique identity number for the purpose of confirming your identity you need to enter that identity number and the country that issued the identity number. (An identity number is usually issued on an Identity Card which contains other personal details such as your full name, date of birth, photograph, signature etc. An identity card can also be referred to as a National Identity Card, Smart Identity Card, Citizen Card etc.)

The information provided on this form, including any information on your health, will be used to assess your health for an Australian visa and may be disclosed to the relevant Commonwealth, State and Territory health agencies and examining doctor(s).

Form 1071i *Health requirement for permanent entry to Australia* provides additional information on Australia's permanent visa health requirements. Form 1163i *Health requirement for temporary entry to Australia* has information on Australia's temporary visa health requirements. These forms are available at offices of the department or from the department's website www.immi.gov.au/allforms/

The information you provide might also be disclosed to agencies who are authorised to receive information relating to adoption, border control, business skills, citizenship, education, employment, health assessment, health insurance, health services, law enforcement, payment of pensions and benefits, taxation, review of decisions and regulation of migration agents.

The collection, access, storage, use and disclosure by the department of the information you provide in this form is governed by the *Privacy Act 1988* and, in particular, by the 11 Information Privacy Principles. The information form 993i *Safeguarding your personal information*, available from the department's website, gives details of agencies to which your personal information might be disclosed.

The *Freedom of Information Act 1982* also relates to your personal information. Under this Act you can apply for access to documents containing your personal information. You or someone authorised to access information on your behalf can apply to do this at any office of the department in Australia. There is no fee for accessing your own information. If you are overseas, you must also provide the Australian mission overseas with an address in Australia to which copies of personal records can be sent. More information on how to make a request under the Freedom of Information Act is given on form 424A *Request for access to documents under the Freedom of Information Act 1982*.

Options for receiving written communications

You may authorise another person to receive all communications, both written and electronic, about your application with the department. You will be taken to have received any documents sent to that person as if they had been sent to you.

To do this you will need to complete **Part O** *Options for receiving written communications* and form 956 *Appointment of a migration agent or exempt agent or other authorised recipient*. For an explanation of what a migration agent or exempt agent or authorised recipient can do please read the sections below.

To change or end the appointment of your migration agent or exempt agent or authorised recipient you must promptly advise the department in writing. You can do this by using form 956 *Appointment of a migration agent or exempt agent or other authorised recipient*.

Authorised recipient information

An authorised recipient is someone you appoint to receive written communications about your application with the department.

All written communication about your application will be sent to your authorised recipient, unless you indicate that you wish to have health and/or character information sent directly to you.

The department will communicate with the most recently appointed authorised recipient as you may only appoint one authorised recipient at any time for a particular application.

Migration agent information

A migration agent is someone who can:

- advise you on the visa that may best suit you;
- tell you the documents you need to submit with your application;
- help you fill in the application and submit it;
- communicate with the department on your behalf.

If you appoint a migration agent, the department will assume that your migration agent will be your authorised recipient, unless you indicate otherwise.

Your migration agent will be the person with whom the department will discuss your application and from whom it will seek further information when required.

You are not required to use a migration agent. However, if you use a migration agent, the department encourages you to use a registered migration agent. Registered agents are bound by the Migration Agents Code of Conduct, which requires them to act professionally in their clients' lawful best interests.

Immigration assistance

A person gives immigration assistance to you if he or she uses, or claims to use, his or her knowledge or experience in migration procedure to assist you with your visa application, request for ministerial intervention, cancellation review application, sponsorship or nomination.

In Australia a person may only lawfully give immigration assistance if he or she is a registered migration agent or is exempt from being registered. Only registered migration agents may receive a fee or reward for providing immigration assistance.

If an unregistered person in Australia, who is not exempt from registration, gives you immigration assistance they are committing a criminal offence and may be prosecuted.

Migration agents in Australia

Migration agents in Australia must be registered with the Migration Agents Registration Authority (MARA) unless they are exempt from registration.

Migration agents outside Australia

Migration agents who operate outside Australia do not have to be registered. The department may give some overseas agents an ID number. This number does not mean that they are registered.

Note: Some Australian registered migration agents operate overseas.

Exempt agents

The following people do not have to be a registered migration agent in order to provide immigration assistance, but they must not charge a fee for their service:

- a close family member (spouse, child, adopted child, parent, brother or sister);
- a sponsor or nominator for this visa application;
- a member of parliament or their staff;
- an official whose duties include providing immigration assistance (eg. a Legal Aid provider);
- a member of a diplomatic mission, consular post or international organisation.

Consent to communicate electronically

The department may use a range of means to communicate with you. However, electronic means such as fax or e-mail will be used only if you indicate your agreement to receiving communication in this way. To process your application the department may need to communicate with you about sensitive information, for example, health, police checks, financial viability and personal relationships. Electronic communications, unless adequately encrypted, are not secure and may be viewed by others or interfered with. If you agree to the department communicating with you by electronic means, the details you provide will be used by the department only for the purpose for which you have provided them, unless there is a legal obligation or necessity to use them for another purpose, or you have consented to use for another purpose. They will not be added to any mailing list. The Australian Government accepts no responsibility for the security or integrity of any information sent to the department over the internet or by other electronic means.

How to fill in this form?

You must:

- complete the form in English;
- print clearly using a pen;
- answer all questions truthfully and completely; and
- provide supporting documents where necessary.

Read the notes for each question. If a question is not applicable, write 'N/A'. Any changes or corrections you make must be initialled and dated by each person who signs the form. If you use any other sheets of paper for providing additional information, each page must also be signed and dated by all persons who sign the form.

If there is not enough space on the form to answer any questions in full, please attach additional sheets of paper with the details.

If you provide incorrect information or documents, it may affect whether you are granted a visa or not, or whether your visa may be subsequently cancelled.
